MCA operates entirely on tuition, fees, fundraising and donations. We do not receive any federal, state, or local government funding.

TUITION DISCOUNTS

- 1) \$200 off tuition for the year if paid in full before July 15th. \$100.00 off biannual tuition (\$50.00 from July & \$50.00 from December payment) if paid before July 15th.
- 2) Families of three or more children enrolled are eligible for a 25% discount off 3^{rd} child's tuition from the same family.
- 3) Students taking approved dual-credit college courses are eligible for a \$100 tuition discount per course, up to two courses. This discount will be credited at the end of the semester upon completion of the course and earning a passing grade.

Please note, only one discount per family. Discounts may not be combined.

NEW STUDENT ENROLLMENT REQUIREMENTS

- Student testing for K3-12th grade
- 6th 12th grade interview with Committee
- Complete new student application
- · Complete enrollment application
- · Provide current shot records and birth certificate
- Signed Student Honor Code Agreement (6th-12th grades)



Enrollment in FACTS system is a requirement for all families. Enrollment in FACTS must be completed the beginning of school. The tuition balance will be paid in 12 monthly tuition payments starting in June and ending in May. Bi-annual payments are due before July 15th and December 15th. Full tuition payments are due by July 15th.

FACTS SIS is how parents can get secure access to their child's data (attendance, grades, homework, etc.) via the web. All MCA families can have access to a FACTS SIS account.

A minimum of \$20 is expected at all times to avoid interruption of cafeteria services.
